### REQUIRED ITEMS TO BE SUBMITTED WITH APPLICATION

1. No Application will be accepted for processing or submission to the Village Plumbing Inspector for consideration unless the licensed plumber has submitted a notarized **Solder, Lead Content Affidavit**.
2. Copy of original Master Plumber's License.
3. Copy of Certificate of Competency issued to the applicant by the Town, City, or Village in the County of Nassau in which he/she was examined for a license.
4. Certificate of Insurance showing:
  - a. General Liability
  - b. Worker's Compensation
  - c. Disability Insurance
5. BOTH application affidavits **MUST** be notarized.
6. One (1) individual photograph of the applicant taken within 30 days of submission of application, 1 ½ x 1 ½ inches in size & such picture must be a true likeness of the applicant and must show only neck, shoulders and uncovered head.

1. Fee **MUST** be paid at time application is filed
2. All fees are non-refundable.
3. All blanks on the Application are to be filled in. If an item is "not applicable" note as N/A. Leave No blanks. **\*\*\*PLEASE PRINT\*\*\***
4. All applicants are subject to Plumbing Inspector and or Village Board approval.
5. No license or permit will be issued if the applicant, business, or principle of the corporation submitting the application has any outstanding unpaid violations due the Village .
6. The license issued by the Village Clerk must be readily available for review by any Village designated authority.
7. All licenses are issued on an annual basis and expire on January 31<sup>st</sup> of each year.
8. All new work, alterations and replacements must be in compliance with the New York State Uniform Fire Prevention and Building Code with regard to water saving devices and all other requirements as set for in that code.
