Trustee Coppola:

New Hyde Park Fire Department

- Annual subscription mailers will be sent out shortly where residents can make an annual donation to the New Hyde Park Fire Department.
- Residents are reminded to dig out the fire hydrant in front of their home during snow storms.
- Everyone is encouraged to check their smoke and carbon monoxide detectors and replace batteries. If detectors are 10 years old or more they should be replaced.

Auxiliary Police

The Village Board thanks the Auxiliary Police and Commander John Concannon who continue to patrol our area and keep our residents safe.

Nassau County Police Department

- Trustee Coppola thanked the 3rd Precinct, Officer Jesse Cooper, Officer Mike Costanzo and the Police Inspectors who have served our community over the years.
- Residents are reminded to lock their car doors and remove valuables from their cars. Car beak-ins are still on the rise in our area.
- They are also reminded keep an eye out for porch pirates, who steal delivery boxes left on the front porch.
- Residents are encouraged to call 911 if they see anyone suspicious on their property who is not supposed to be there.

Zoning Board of Appeals

LED Lights

The Village Board is looking into replacing the sodium street lights with new LED lights throughout the Village. The sodium street lights are out of date and replacement parts are hard to come by. Installing LED lights would save the Village thousands of dollars in energy costs.

Tree Committee

Any resident interested in having a tree planted in front of their home can contact the Department of Public Works and sign up for one. To date there are 30 residents seeking new trees be planted in front of their property.

Milena's Garden Center will be planting in the center mediums on Jericho Turnpike this upcoming week, as well as around Village Hall, for the spring season.

Reminder to everyone that April 26, 2021 is Earth Day and April 30, 2021 is Arbor Day. Trustee Pallisco encouraged everyone to get involved.

Trustee Pallisco thanked the Village Board and the Village Family for allowing him to serve the Village of New Hyde Park for the last 19 years.

Trustee Burger:

Veterans Affairs

- All events for American Legion Post 1089 have been canceled due to Covid-19 concerns.
- Plans for Memorial Day are on the way. The ceremony will be held at Village Hall, however there will be no parade. The Legion is thinking of putting on a car parade. Plans have to be made with Nassau County and will be announced as soon as they have been worked out.
- A Mass will be held in Holy Spirit for Memorial Day.
- The American Legion lost three aging members in the last couple of months.
- Commander John McGuire will be stepping down from his position which will be taken over by Commander Bill Hothan on June 30, 2021.

Building Report

- The last Village building court was held on March 17, 2021, via telephone conference. There were 16 cases on the docket, involving property maintenance, violation of special exception, working without a permit, illegal use of a single family home, illegally parked on lawn, and placing snow on street.
- The next Village building court will be held on April 21, 2021 at Village Hall, with 10 cases on the docket.
- There have been 11 permits in total approved and issued from March 4th to March 18th.

Trustee Burger thanked all exiting Board Members and wished them the best of luck, as well as congratulating the newly elected members of the Board.

LIRR

- There has been one accident and one tragic event that took place at the LIRR construction sites in the last two
 weeks, which has prompted MTA to put out a work stoppage until all investigations into the incidents have
 been completed.
 - o At the Willis Avenue crossing, there was a wall collapse of a partially demolished building. No construction crew was hurt in the collapse.
 - At the Mineola station pedestrian bridge, a worker was electrocuted when a crane touched a live wire, electrifying the bridge. The worker is in critical condition. The Village Board wishes her and her family all the best.
- G-14 substation construction is ongoing.
 - The delivery date for the prefabricated structure originally set for March 19th, was changed due to the work stoppage order. The date has been pushed back by a week. New dates for delivery will be announced on the Village Website.
- Platforms have re-opened at the New Hyde Park train station.
 - o Construction is continuing at the station house.
 - The platforms can now accommodate a 10 car train. The full platform will be reopened once S 12th Street has been completed.
 - o A new commuter lot has opened on the corner of Plaza Avenue and New Hyde Park Road.
 - There is also available parking on 2nd Avenue and 3rd Avenue.
 - Residential parking lots are still located on S 12th Street. The walk to get from one side of the platform to the other is quite long. The pedestrian bridge is set to open in September.
- No night work has been scheduled for the next several weeks.
- Wall construction is set to begin within the next month, from Premier Boulevard to Covert Avenue. The south side of the wall is set to be completed first and then work will begin on the north side.
- Truck access and parking plan for 2nd and 3rd Avenues are currently being updated. The corner of 3rd Avenue and Covert Avenue extension will be changed in order to accommodate larger trucks from making a turn onto 3rd Avenue.

Water Authority

Construction at Station 57 has been on track with no new developments.

Trustee Burger detailed the route of the materials being delivered to the G-14 substation. The detailed route will be posted on the Village website. Materials will be trucked in via 7 trucks during the nighttime hours while installation will be done during the daytime. Trustee Pallisco questioned why New Hyde Park Road is not being used. Trustee Burger will look into that.

Village Hall

- The side entrance staircase has been completed. Before it's opened to the public hand railing has to be installed. Two new planters were built alongside the new stairs.
- Estimates are being gathered to update the bathrooms at the Village Hall to be ADA compliant. The monies used will be from last year's CDBG grant.

Upcoming changes to scheduled meetings:

- An additional staff meeting will be added in on March 25th between the exiting members of the Village Board and the newly elected members.
- Swearing in of newly elected officials will be on April 1st.
- There will be a staff meeting on April 8th.
- Budget hearing will be held on April 15th and it will be adopted on April 29th.

MyVnhp

Trustee Squicciarino reminded residents to download the MyVnhp app from the app store and use it when requesting trees, reporting pot holes, receiving alerts and all other Village needs.

Schools

The NHP-GCP school district will hold a budget hearing on April 12th. Sewanhaka school district will hold a budget hearing on April 13th.

Chamber of Commerce

Chamber of Commerce will hold a ribbon cutting ceremony on April 26th to welcome Park Place Restaurant and Bar to our community.

Hillside Library

Residents can go online to sign up and reserve a time to browse the aisle. The library is also offering a variety of virtual programs and events. All residents are encouraged to sign up.

Parks and Recreation

On April 22nd park facilities will open at Memorial and Nuzzi Parks. Park attendants will be on site if needed by the park patrons.

Mayor Montreuil added that residents should be aware that dogs are not allowed in Village parks.

Mayor Montreuil:

The Mayor held a zoom meeting with the residents of Millers Lane in regard to traffic on their street. Eight residents were present and it was discussed to make Millers Lane a one way southbound street. A survey will be sent out to all residents of Millers Lane as well as the surrounding streets and a public hearing will be held to find out residential opinion.

Department of Public Works

Per Deputy Superintendent Sikiric:

- Memorial and Nuzzi parks have been aerated and seeded. Maintenance was done in preparation of the facilities opening at both parks.
- Pothole repair on Village streets is on the way.
- Old and outdated signs are being replaced around Village streets, in particular near the railroad station.
- The staircase in front of Village Hall has been repaired. Railing is to be installed next week.
- The Village landscaping company will be planting bushes and flowers next week at Village Hall.

Trustee Burger suggested that when DPW is surveying the streets needing repair, all repairs that are the direct result of the LIRR construction project, should be noted. It will then be submitted to 3TC for reimbursement. Deputy Superintendent Sikiric stated that those repairs will be tracked separately.

Dvirka and Bartilucci has been commissioned to do a Village wide survey of all the roads. Per the survey the Village will be able to determine which roads need repair, as funds become available.

Village Board is working with the MTA on an amendment to the original MOU in regard to truck turning radius from Covert Avenue onto 3rd Avenue, as well as parking along the railroad and the new parking lot. The amendment should be revised shortly. The MOU revision will also include the funding for the DPW garage. That would include \$2 Million from the project, and \$3 Million still owed by NYS. The Village will be sending out the bid for the garage construction in the near future.

Mayor Montreuil thanked Clerk-Treasurer Hillmann for having Village Hall painted. The new paint job looks bright and cheerful. He also thanked Superintendent Pillay for getting the estimates for the restroom and stair repair at Village Hall.

Public Participation:

A resident stated that the freight trains going through New Hyde Park station have been moving at a slow rate of speed, to prevent damaging the rails. Because the Brookhaven landfill is closing the number of trains passing through our station will increase by tenfold. The resident suggested the trains in the future stay at the slow rate of speed to prevent damages to our tracks as well as vibrations. Trustee Burger will ask for more information at the next meeting with the MTA in regard to the freight trains passing through.

Resident Ann Stevenson thanked the Board members leaving and welcomed the newly elected members of the Board. She questioned if the New Chef Wong's restaurant is under new ownership. Per the application submitted to the Clerk's Office, the ownership of the restaurant has not changed.
