# **Trustee Coppola:**

#### Little League

# **Auxiliary Police**

The Village Board thanks the Auxiliary Police who continue to patrol our area and keep our residents safe. Commander John Concannon will be invited to speak at a board meeting to give residents more information in regard to the Police Auxiliary.

# **New Hyde Park Fire Department**

Residents are reminded to dig out the fire hydrant in front of their home during snow storms. If your house number sits too low and is covered by snow have it moved higher up, if possible, in case of an emergency.

# **Nassau County Police Department**

# **Zoning Board of Appeals**

• The last meeting of the Zoning Board was held on February 10, 2021 with one case on the docket:

- 500 N 3<sup>rd</sup> Street Approval was granted to the applicant seeking to maintain a second above grade kitchen that was being utilized by their mother under a special exception permit, and will now be utilized by their son.
- The next meeting of the Zoning Board is scheduled for March 10, 2021. There are no cases on the docket at this time.

#### Architectural Review Board

- The last meeting of the Architectural Review Board was held on March 3, 2021, with one case on the docket.
- The next meeting is scheduled to be held on April 7, 2021, with one case on the docket:
  - o 402 Brown Place The applicant is seeking approval to a change in materials.

### **Tree Committee**

Any resident interested in having a tree planted in front of their home can contact the Department of Public Works and sign up for one. They can also use the GoGov app or our website to put in a request.

# **LED Lights**

The Village Board is looking into replacing the sodium street lights with new LED lights throughout the Village. The sodium street lights are out of date and replacement parts are hard to come by. LED is energy saving and would save the Village money in the future.

There was a Tree Trimming Bid that was put out by the DPW department. Several requests were received. The bids are currently being analyzed but no contractor has been chosen at this time.

# **Trustee Burger:**

# **Building Report**

- The last Village building court was held on February 17, 2021, via telephone conference. There were 18 cases on the docket, involving property maintenance, violation of special exception, working without a permit, illegal use of a single family home and illegally parked on lawn.
- The next Village building court will be held on March 17, 2021 via telephone conference, with 14 cases on the docket.
- There have been 11 permits in total approved and issued from February 18<sup>th</sup> to March 4<sup>th</sup>.

#### LIRR

- Construction is continuing on both the station house and the platforms.
  - o The canopy at the platforms is currently being installed.
  - o The track conversion re-commissioning occurred on February 27<sup>th</sup>. Eastbound track was renamed Track 1, future third track was named Track 2, and westbound track was renamed Track 3.
  - o The 10 car platform will open March 15<sup>th</sup>, while the 12 car platform will open in the summer 2021, with the pedestrian underpass September 2021.
  - o Before the reopening of the new platform 3TC has to clean up the area of all construction materials.
  - New parking lot has to be freed up for commuters as well as 2<sup>nd</sup> and 3<sup>rd</sup> Avenues.
  - O Village Board requested a vehicle and pedestrian access logistical map, similar to what was provided when the temporary platforms were originally opened.
- Work continues on S 12<sup>th</sup> Street.
  - Pedestrian passageway will be prefabricated and will be pushed into place on April 24<sup>th</sup>. There will be a double track outage that weekend so work can be completed.
  - o The pedestrian underpass should open to the public around September 2021.

- MTA and 3TC doing work at the right-of-way. There will be some night work in the area, which has not been announced yet.
- There has been no new updates on the wall construction. 3TC is awaiting material and fencing to be delivered in order to continue.
- G-14 substation construction is ongoing.
  - The delivery date for the prefabricated structure will be on March 19<sup>th</sup>. The pieces will be trucked in via 7 trucks (2 carrying transformers, 5 carrying substation materials).
  - o Delivery of materials will be done during the nighttime hours while the installation of the substation will be done during daytime.
- Truck access and parking plan for 2<sup>nd</sup> and 3<sup>rd</sup> Avenues are currently being worked on. The Village Board along with 3TC and the MTA is looking into modifying the corner of 3<sup>rd</sup> and Covert Avenue extension to accommodate larger trucks.

# **Water Authority**

- Demolition to the building at Station 57 was completed.
- Foundations and footings continue for the buildings.
- Wellhead treatment is currently being installed at the site.

#### **Veterans Affairs**

All events for American Legion Post 1089 have been canceled due to Covid-19 concerns. Plans for Memorial Day are on the way. The Legion is thinking of putting on a Memorial Day car parade. Plans have to be made with Nassau County and will be announced as soon as they have been worked out.
