RE: Incorporated Village of New Hyde Park Rental Registration Law

Dear Sir or Madam,

At the Public Hearing of November 1, 2005, which considered for adoption a rental registration law, the Village's Board of Trustees adopted Local Law No. 1 of 2005 (codified as Chapter 196 of the Municipal Code) which provides for the mandatory licensing of Rental Dwelling Units throughout the Village in Mixed Occupancy Buildings and Multiple Dwellings (refer to Local Law No. 1 of 2005).

A letter was sent to property owners of mixed occupancy and multiple dwelling buildings in the Village of New Hyde Park along with the required forms to be completed. Pursuant to Section 196.9, Rental Registration Permits are valid for a period of two years from the date of issuance. Therefore, it is time to renew your permit application.

- The Rental Occupancy Permit Application (Form A) must be completed if there have been **changes to the building/structure.**
- Rental Registration Application (Form B) must be completed if there have been **changes in occupancy.**
- The Rental Renewal Application (Form C) must be completed only if there are no building or occupancy changes in what you reported.

Please complete the appropriate application, attach the proper permit fee (refer to fee schedule on next page) and send to the Village's Building Department. Upon receipt of your completed application and renewal fee, pursuant to Section 196.12, the Building Department will make the necessary arrangements with you in order to inspect the rental dwelling units in your building as identified in your application.

Your completed application and renewal fee must be submitted on or before September 30, 2021 (refer to Local Law 1 of 2005, Section 196.19). Your failure to submit the required application and renewal fee on or before September 30, 2021 will render you in violation of Chapter 196 so please be timely with your paperwork.

For your convenience, detailed instructions for the completion of each application are enclosed. Should you have any questions regarding the requirements of Chapter 196, please do not hesitate to contact my office.

Finally, in the event that the tenancies referred to in your Rental Occupancy Permit application should change in the future, the Rental Registration Application will need to be completed by you and submitted to the Building Department noting such changes (refer to Local Law No. 1 of 2005, Section 196.15).

 - A. A property survey of the premises drawn to a scale not greater than forty (40) feet to one (1) inch.
 - B. If not shown on the survey, a site plan, drawn to scale, showing all buildings, structures, walks, drives and other physical features of the premises and the number, location and access of existing and proposed on-site vehicle parking facilities.
 - C. If new construction, alterations or improvements are being made, a properly prepared building permit application.
 - D. A copy of the Certificate of Occupancy and Certificate of Completion, if any.

In consideration of being granted the Permit hereby applied for, it is agreed that the applicant will comply with the requirements of the Building Department of the Village now in force or which may in the future be promulgated for Rental Registration. Falsification of any statement made herein may be punishable under penalties of perjury and will result in revocation of the Permit.
