#### **Public Information**

Renovations on the children's playground is ongoing and the park remains closed during construction. There are many projects going on; children's playground has been excavated and is awaiting new playground equipment. There will be a Senior area and electricity will be run to the new event area. Installing a new park house with ADA accessible bathrooms

We are in the process of receiving proposals to resurface both basketball courts. The scope of the work will be to repair the cracks, apply two (2) coats of acrylic and apply two (2) coats of deco color to the courts. New white lines and three (3) point lines will be painted as well as new Pickle Ball lines on both courts.

# **Department of Public Works:** Igor Sikiric, Superintendent

- Department of Public Works continues performing daily maintenance activities and cleanup on a routine basis.
- Department of Public Works continues to demo and excavate old kiddie park at Memorial Park and the excavation is almost complete. Grading will begin soon.
- Department of Public Works has been changing any old or damaged street signs and/or posts.
- Sanitation collections are on a normal schedule. Grass clippings will begin to be collected the second Wednesday in April.
- Department of Public Works painted the shamrocks in the street, and placed signs and flags for the St. Patrick's Day parade.

# Long Island Railroad (LIRR) 3<sup>rd</sup> Track Project

#### **G-14 Electrical Substation**

• The work to push out the curb has been completed except for the paving and landscaping which will take place in April/May.

#### South 12<sup>th</sup> Pedestrian Underpass

- The chain link fence was removed and permanent fencing has been installed.
- Currently finishing up some electrical work.

#### Wall Construction – Fencing

- 3TC has been non-responsive in terms of the mock-up we are looking for.
- Some temporary utility poles are being removed.

#### Roads

- Still on track for the spring in respect to 2nd and 3<sup>rd</sup> Avenues, just waiting on a date.
- We are continuing discussions with the MTA regarding paving Stewart Avenue to the DPW facility, 4<sup>th</sup> Avenue and S. 12<sup>th</sup> Street to New Hyde Park Road.

#### 3<sup>rd</sup> Avenue

- The Village has received a few complaints from local business groups due to the striping being problematic for the business' deliveries.
- The Board and the chamber took a walk along 3<sup>rd</sup> Avenue over the weekend and determined some areas need to be redone.

#### **LIRR Track Work – Service Outages**

• The Village is not aware of any service outages in the near future although there is always the potential for night work.

#### Streetscape

- The Board will be meeting with WSP in executive session this evening regarding beautification.
- The Village Board will continue to provide the public updates on the progress.

#### **NHP Road Safety Concerns**

- There have been enhancements made; speed limit markings and the county installed pedestrian walking signs.
- The Mayor, Trustee Burger and Rich Nicollelo met with the county today regarding Left turn signal (protected signal) at New Hyde Park Road and Plaza Avenue. The Board is receiving push back. Continuous back and forth between 3TC and the MTA on who's responsibility it is to move forward with getting this done. The next step is to contact the MTA directly.

#### **Memorial Park**

- Electricity will be installed by the VNHP Pride Memorial Park sign which will serve as a focal point for concerts and events.
- The Village has a grant from Nassau County and we are actively looking to redo the house which has a leak in the roof and desperately needs new bathrooms.
- The Board has designs on expanding the Memorial side of the park.
- New fencing. The current fencing is over 25 years old and a safety issue.
- Resurfacing the basketball courts.
- Adding a sprinkler system in the outfield.

#### Nuzzi Field and Department of Public Works

- The Village has 5.1 million dollars set aside but unfortunately it will cost more than that. We are constantly looking for ways to generate revenue.
- Nuzzi Field will be restored to its full glory once the DPW building is completed.
