## Parks and Recreation

Renovations on the children's playground is ongoing and the park remains closed during construction. There are many projects going on; children's playground has been excavated and is awaiting new playground equipment. There will be a Senior area and electricity will be run to the new event area. Installing a new park house with ADA accessible bathrooms.

We are in the process of receiving proposals to resurface both basketball courts. The scope of the work will be to repair the cracks, apply two (2) coats of acrylic and apply two (2) coats of deco color to the courts. New white lines and three (3) point lines will be painted as well as new Pickle Ball lines on both courts.

# Department of Public Works: Igor Sikiric, Superintendent

- Department of Public Works continues performing daily maintenance activities and cleanup on a routine basis
- This time of year is especially busy with lawn cuts, weed whacking and watering all along the LIRR corridor as well as Jericho Tpke.
- Baseball field maintenance.
- Department of Public Works completed the demo and excavation of the old kiddie park at Memorial Park and they will begin to level the surface for equipment installation.
- Sanitation collections are on a normal schedule. Grass clippings collection began Wednesday, April 12<sup>th</sup>. To date, the sanitation crew removed 617 tons of refuse and 43 tons of yard waste.
- Department of Public Works assisted with Earth Day by creating planting beds and removing a tree.
- Department of Public Works completed 25 tree trims and 6 tree removals.
- Department of Public Works will continue pot hole repair. With the warmer weather approaching, hot patch can now be used for the deeper and larger holes.
- The tree inventory process is complete and we anticipate a report within a few weeks.

### **Zoning Board of Appeals**

- The last meeting was scheduled for April 13, 2023 with one application being heard; 1525 Lincoln Avenue front and side yard was approved.
- The next meeting is scheduled for May 10, 2023. As of today, one application has been submitted; 500 1st Avenue 2 story rear addition.

# **Trustee Burger**

Long Island Railroad (LIRR) 3<sup>rd</sup> Track Project

#### **G-14 Electrical Substation**

• The landscaping is complete and we are pleased with the outcome.

#### South 12th Pedestrian Underpass & Station Platform

- Trustee Burger met with 3TC on April 3<sup>rd</sup>.
- The electrical work is complete and the fencing around the platform is going up.
- 3TC is looking into options to clean up the façade. The current mock up is not acceptable.

#### **Paving of Roads**

- The paving for Stewart Avenue and 4<sup>th</sup> Avenue was completed in mid-April.
- Included in the agreed upon plan are 2<sup>nd</sup> Avenue, 3<sup>rd</sup> Avenue, Baer Avenue, and portions of South 12<sup>th</sup> Street. The Village is waiting on a paving schedule.
- 3<sup>rd</sup> Avenue Striping will be redone to accommodate local business operations.

#### **LIRR Track Work**

• The Village is not aware of any upcoming outages.

#### Nightwork/Road Closure

• There are no scheduled road closures at this time, but as the MTA continues rail work, the possibility remains.

### 2<sup>nd</sup> and 3<sup>rd</sup> Avenue Streetscape

- The Village is meeting with WSP monthly. The focus of the last meeting on April 6<sup>th</sup> was the South 12<sup>th</sup> Street Parking lot.
- Once the Village receives a decent plan that balances out green space, parking and a functional area, the Board will share this plan with the residents to obtain feedback. We anticipate being ready to show a plan at the next Board meeting.

#### Water Basin 21 (Area Across from DPW – Not Village Property)

- The County permitted 3TC to use the area as an access point to the Hempstead Line Tracks.
- The Board is currently working with the County to get the area restored.

### **NHP Road**

- Left turn signal (Protected Signal) at New Hyde Park Road and Plaza Avenue.
  - Installation is at a standstill due to a funding dispute between the County and MTA.
  - The last meeting was held on April 5<sup>th</sup> without a resolution.
- The fence at the underpass that was damaged by the February accident was ordered by 3TC. The Village does not have a date for repair/installation as yet.

#### **Water Authority**

- The well at Station 57 Rehabilitation project including 1.4 Dioxane Removal is operational.
- Well Station 57A is still undergoing testing.

#### Veterans Affairs/American Legion Post 1089

- The last meeting was held on April 8<sup>th</sup>. The next Meeting will be on May 6, 2023
- The Legion is currently coordinating a Vet Dog Event on May 20th at Memorial Park.
  - Donation Boxes are out, one is located in the foyer at Village Hall.
  - The event will be held in Memorial Park at 10:00 am on Saturday, May 20th.
  - The team met yesterday to coordinate the logistics in the park.
- Memorial Day event planned.
  - The Memorial Day Tribute Parade will be held on Saturday, May 27, 2023. We will assemble at 9:30 am on Hillside Blvd. The parade will step off at 10:00 am.
  - There will be a small ceremony at Village Hall and then a larger ceremony at Memorial Park.
- Post 1089 will be sponsoring NHP Memorial Student Varun Pillai for Boy State 2023.
  - Boy State will be held at SUNY Morrisville from June 25<sup>th</sup> through 30<sup>th</sup>
- The American Legion would like to thank one of its members, Gerald Pecard, for his generous donation of \$3000 to the post.

#### Troop 298

• The Troop will be hosting a car wash on Saturday, May 13<sup>th</sup> in the Lakeville Road Parking lot from 9:00 am to 3:00 pm. The payment amount of having your car washed is at your discretion.

• Troop 298 is working on two (2) Eagle Project moving forward at Memorial Park. One (1) is for additional exercise stations. This will take place weekend of June 2<sup>nd</sup> thru the 4<sup>th</sup>. The second (2) is Memorial Flags to honor our war dead from New Hyde Park. This is still in the planning stages.

#### **Noise Abatement**

- TVASNAC (Town-Village Aircraft Safety Noise Abatement Committee) meeting was held on March 27, 2023.
- Town of Hempstead has appointed a new attorney to represent TVASNAC since the previous attorney has retired.
- There is still no response to letters written from Town Supervisor Don Calvin and Nassau County Legislator Rich Nicolello to our federal government officials regarding the overuse of runways, noise, health concerns and quality of life issues for residents affected along flight paths.
- A letter was also written by TVASNAC to the Nassau County Department of Health urging them to test
  the air quality along certain flight paths. Assemblyman Ed Ra is looking into bill A 2140 signed by
  Governor Houchul which gives N.Y. State approval to spend \$500.000 dollars for the study of aircraft
  noise and human studies. TVASNAC is looking to invite Congressman Anthony D'Esposito to the next
  meeting in May 2023

#### **Events**

- Earth Day was a success. Thank you to the Cultural Commission team, Department of Public Works, Tommy Kane, Scout Troops and some Little Leaguers that came out to help clean up and plant. The focus of the day is on the kids simple and fun. Thank you to all involved.
- Our Annual Memorial Day Parade will be on Saturday, May 27<sup>th</sup>. We will assemble on Hillside Blvd and Jericho Tpke at 9:30 am and will step off at 10:00 am. Please make every effort to attend.
- This year's Multicultural Festival will be on Friday, June 9<sup>th</sup>. The High School always goes above and beyond to assist with this event and we are excited for this year's collaboration.

## **Summer Camp**

- The Village Summer Camp will run from July 5<sup>th</sup> through August 4<sup>th</sup>.
- The approved hours for the camp are five (5) hours a day broken up into two sessions; 10:00 am 12:30 pm and 1:30 pm to 4:00 pm.

# **Mayor Devane**

Mayor Devane provided an update he received from Newsday; the State Budget does not include Gov. Hochul's housing plan. We won't know for sure until the state budget passes. We will continue to fight the plan moving forward.

Mayor Devane wished everyone a Happy Easter and Eid Mubarak.

Mayor Devane clarified that the work done at Village Hall on Easter Sunday was authorized by him as an emergency repair on the sprinkler system need to be tended to.

Mayor Devane stated that residents may have noticed a boat parked in the Central Blvd. parking lot across the Street from Village Hall. Mayor Devane wanted to make clear it was not authorized by the Mayor or the Village Board. The Village does not allow the storage of boats on any Village property.

#### **Memorial Park**

- The Village is simultaneously working on the bathrooms, bocce ball court, basketball courts.
- The Village was informed if all goes as planned, we can optimally open by Memorial Day weekend.
- The bathrooms are almost complete in addition to a new roof. A small overhang with a table and chairs on the south side of the park house.
- The children's playground is a lot more detailed than anticipated. The equipment will arrive on April 24<sup>th</sup> and installation will take approximately four (4) to six (6) weeks.
- Opening of the dog park, tennis courts and basketball courts will be by the second week of May. Access will be limited to those areas and will be subject to closure for equipment trucks coming in. Safety is the Villages main concern.
- The new steel fence will encompass the border of the park; William Street, Lincoln Avenue and Albert Street. The park will have four (4) exits.
- The Village is looking into adding Wi-Fi to the park.

#### Village Hall

- The Board Room is being relocated to the 2<sup>nd</sup> floor. The current Board Room will still be utilized for court, when in session and it will also be a general community room, especially geared towards the seniors.
- The Community Room is complete. The office of Laura Trentacoste, our Senior Program Coordinator, will be located in there as well.
- The outside of the building needs work. We are getting estimates on painting the outside of the building, repointing the brick work.

## **Department of Public Works**

• The Village met with Calgi, a design company and told them our budget was 5.1 million dollars and they came up with a plan to get the DPW facility done.

#### **Marcus Christ Hall**

• The Village Board will be presenting a plan to the public in the near future.

#### Miller Bros.

- The discussions are still a work in progress, but the Village is in constant contact with the owner.
- The Village is hoping to share plans with the residents in the near future.

#### **Taxes**

• The Mayor stated that he was the one who communicated to the residents that the Village would be returning the \$100.00 increase imposed on last year's taxes. This was presented with every intention to do so but unfortunately prior to estimates of outstanding projects received. The increase in materials and labor costs have left the Village unable to fulfill that promise.

Mayor Devane asks all the residents to come on out for the Memorial Day Parade on Saturday, May 27th at 10:00 AM rain or shine.

Mayor Devane also thanked Milena's Garden Center for donating flowers for Earth Day.

Church of the Holy Spirit's Annual Family Festival will be held on June 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> of 2023.
