# Department of Public Works: Igor Sikiric, Superintendent

## Sanitation September 2024

- 566 tons of refuse and recycling consisting of:
  - 400 tons of MSW
  - 12 tons of newspaper
  - 20 tons of commingled recyclables
  - 107 tons of yard waste
  - 27 tons of construction debris
- There are two double days scheduled before the next meeting:
  - Election Day, Tuesday, November 5<sup>th</sup>, there will not be a sanitation collection. Collections will resume on Wednesday November 6th which include, garbage collection on the South side, cardboard/paper will be collected on the North side, Commingled Recyclables and Yard Waste will be collected throughout the Village.
  - Veterans Day, Monday, November 11<sup>th</sup>, there will not be a sanitation collection. Collections will resume on Tuesday November 12th, with garbage collection throughout the Village and paper/cardboard collection on the North side.
- Bulk waste and E-waste pickups can only be scheduled by calling Village Hall. Bulk waste is collected every Monday and Friday. E-waste is collected on Wednesdays.
- Cardboard must be flattened and bundled; no full boxes or boxes with garbage or Styrofoam inside will be collected.
- Do not put your cardboard out for collection with your bottles and cans, it will not be collected.

#### **Operations**

- Road side leaf collection will begin on Monday November 4<sup>th</sup> and continue as needed till December 13<sup>th</sup>.
  - Road side leaf collection is strictly for loose leaves; do not put branches within leaf piles.
  - If you have leaves to dispose of now, they can be bagged and put out for collection on Wednesdays.

#### **DPW**

• Installation and repair of new signs and poles due to aging and damage is on-going. Approximately 25 signs were repaired, replaced, or relocated in September

- DPW staff performed weekly maintenance and cleanup operations along Jericho Tpke, LIRR corridor, and parking lots. Litter pick-up along sidewalks, median areas, and parking lots is conducted on a weekly basis.
- All vegetation watering and maintenance is conducted weekly or as needed.

#### **Routine Tree Maintenance**

- Routine tree maintenance requests and tree preventative maintenance procedures are on-going and will continue as needed.
- DPW conducted 15 tree trims and 4 tree removals in September.
- Our Tree Contractor was in the Village in September and performed 30 tree trims, 5 removals and 10 stump removals.
- Tree trims and removals will continue next month. If you have any requests, you can call Village Hall or use the MyVNHP App.
- During the month of September, DPW received and staff responded to approximately 45 service requests that were received via the MyVNHP App or phone calls to Village Hall. The majority of calls this month were regarding trees.

### **DPW Renovation Update**

- We are now 3 months into the DPW renovation project and all demolition has been completed which included the front section of the main garage, the salt shed, our old office trailer, and storage building.
- The contractor is currently working on renovating the main garage section with new electric, structural repairs and new bathroom.
- The foundation work for the new truck garage is now complete and the foundation and wall for our new recyclables transfer area has been completed.
- The next steps will be to excavate and begin the foundation work our new office building.
  - It is anticipated that all foundation work would be completed before the cold weather sets in and all structural work will begin after the new year.

# **Building Department - Binu Pillay, Superintendent:**

#### **ZBA**

- The last scheduled meeting of the Zoning Board and Appeals was Schedule for October 9<sup>th</sup>; but it was cancelled since no applications were submitted by the deadline.
- The next meeting is scheduled for Nov  $13^{th}$  and currently no cases have been submitted; the deadline is 10/23/24.

#### ARB

- The last meeting of the Architectural Review Board was held on September 25<sup>th</sup> with 3 cases heard; 2 cases were about changing siding color which were approved; and one case was about adding an awning and a portico over an existing front stoop and replacing siding with stucco which had a reserved decision since the board could not approve the color.
- The next meeting is scheduled for October 23 with 2 cases to be heard which comprise of (2) new 2<sup>nd</sup> floor additions; change of siding; and complete interior renovations.

#### **Planning Board**

- The last meeting of the Planning Board was scheduled for September 25th; however, no applications were submitted and the meeting was cancelled.
- The next meeting is scheduled for October 23<sup>rd</sup> and as of this time we have no applications submitted

#### VILLAGE COURT

• The last Village Court was held yesterday, October 1 6<sup>th</sup> with 43 cases, which comprise of: 3 sidewalk obstruction; 16 property maintenance; 2 garbage out before 7pm; 17 working without a permit; 2 Truck idling; 2 rentals without registration; and 1 illegal use within place.

• The next village court will be held on Nov. 20<sup>th</sup>, with 23 cases, which comprise of: 1 obstructing sidewalk; 7 property maintenance; 8 working without permits; 6 multiple family in a single family rental registration; and 1 use of truck for non-permitted route.

#### RENTAL REGISTRATION

• Rental registration is in process and inspections are being conducted accordingly

#### SPECIAL USE

- There was no special use cases heard last month or tonight

- During the period from September 19 to October 17, the building department issued 42 permits; 11 building permits; 11 plumbing permits; 6 roof permits; 3 sidewalk/driveway permits; 2 fence permits; 4 street opening permits; and 5 solar permits.

# <u>Trustee Rainer Burger – Reported by Laura Daly:</u>

Long Island Railroad (LIRR)  $3^{rd}$  Track Project - Punchlist Signage

- One way signage and no left turn signage has finally been installed
  - Site walk was completed on Oct 9 with 3TC, Igor and Rainer signage is all complete

• Project is Closed.

#### LIRR Track Work

- No Track work planned
  - Some minor asphalt/paving work by Station house this week and next week.

#### **Water Authority**

- Water Authority is ordering up a new reactor for Well 57A to get it to 100% capacity (operating at 73%).
  - Bid specifications are complete and the reactor itself is scheduled to arrive in mid-December.
- There are currently 3 other major projects physically underway which include Station 44 Rehabilitation (4 wells) Elmont, Station 40 Emerging Contaminants (2 wells) New Hyde Park and Elevated Tank 20 Rehabilitation Elmont.
  - The Station 44 rehabilitation project has now stepped up the pace for Phase 1. The 1st well building foundation is formed out and the clear-well walls have been poured. New gas main to the site is expected to be installed on October 18<sup>th</sup> for new emergency generator.
  - Physical work at Station 40 (HQ) has begun. Retaining walls on south and east perimeters are being poured on October 17<sup>th</sup> and 18th.
  - Tank 20 (Elmont) Rehabilitation should have been completed in July 2023. However, the contractor had stopped work for failure to pay Union health benefits. Tank 20 (Elmont) rehabilitation contractor has finally returned to site and blasting exterior bowl.

#### **Noise Abatement**

- Last TVASNAC Meeting was Sep 22<sup>nd</sup>; the next meeting will be on Oct 28th
  - Meetings are held at Hempstead Town Hall and start at 7pm.
- Town of Hempstead attorney has filed a foil request to the FAA for the raw data from noise monitors placed along the departure and arrival routes of planes going into JFK. The FAA reported that the town was supposed to receive these reports on July 29. Reports are now coming in September as the Port Authority keeps stalling. Have not heard if the reports have come in.
  - If response is not received Town of Hempstead and North Hempstead will move forward with Legal Action.
  - Residents are urged to file online noise complaints at <a href="www.hempsteadny.gov/TVASNAC">www.hempsteadny.gov/TVASNAC</a>.; or for Hempstead residents to call 1-800-225-1071, North Hempstead residents dial 311.

  - The Board and Mayor met with the Engineers and Architect and looked a various value engineering options to reduce cost which included reducing the size of the overall footprint.
  - The updated bid package is expected by the end of October and will hopefully go out to bid in November
  - Budget: Estimated approximate \$2.5 million currently have \$1.1 million Bond remainder
    - o The Mayor subsequently updated the estimate to between \$3 and \$4 million

  - Binu met with the manager twice to have the volume lowered.
  - They have turned the volume down and there were no complaints as of Oct 13, 2024.

### **Community Development Block Grant (CDBG):**

- We were able to retrieve \$50,000 pending funds from the 48th year that we were waiting for
  - To clarify, the Village first spends the money and then sends invoices for reimbursement
- We applied for a new grant, the 50<sup>th</sup> year, but we were not approved for what we hoped for, primarily due to ADA requests being denied. We will follow up and appeal that decision

- The Village was a donation center for the victims of Hurricane Helene in North Carolina
  - Thanks to the efforts of Cheryl, who has been in contact with the communities in North Carolin, we put together this 2-day event
  - Focus changed from clothing and non-perishable items, to cleaning supplies, building supplies and most recently to food
  - People came from other towns to donate
  - Lance Belcher, owner of Doodyman, has a brother in Chimney Rock, NC and the most recent request was for food
  - Within a couple of hours, we had donations from the Lakeville Bakery and the Nuzzi Family of: 2,000 loaves of bread, 250 lbs. of butter, 450 dozen eggs, 250 lbs. of bacon and 250 lbs. of cheese
  - The community donated time taking in the collection and loading the trailer; North Shore Neon Signs for donating the 53ft trailer; Cyril and Coleen Kearney for donating the cab and driver
  - Truly heartwarming that a community can come together to help out strangers in another community
- The Village finally closed on 300 S 12th Street
  - The state approved and provided the funding
  - Wasting no time; the plan is to demo that area by early November (for free by a village resident) and make it into a new parking lot
